The Members,

Your Directors have pleasure in presenting their 11th Annual Report and Audited Accounts for the eyear ended on 31st March, 1999.

1. FINANCIAL RESULTS :

The financial performance of the Company for the year under review is as follows:-

2. OPERATIONS:

During the year under review, the company achieved total Turnover of Rs. 178.64 Lacs as compared to Rs. 130.88 Lacs in previous year. Loss before depreciation for the year was Rs. 0.07 Lacs as compared to Loss of Rs. 22.10 Lacs in the previous year.

The company has successfully marketed and implanted the first Introduction in India of Non-Programmable Pacemakers by the name of Shree Ventralith-I. The products have been well accepted in all major hospitals of the country as well as abroad.

3. EXPORTS:

During the year under review, the Company has achieved Export Turnover of Rs. 20.11 Lacs as compared to Rs. 14.88 Lacs in the Previous year.

4. FUTURE PROSPECTS AND DEVELOPMENTS:

The Directors feel that the future of the Cardiac Pacemakers manufactured by your Company is encouraging as it will be more competitive than the imported pacemakers. Export of Pacemaker have doubled with the acquiring of CE (Conformity Certificate) from Europe. The Company is exporting regularly to Greece, China and surrounding countries with enquiries from all over the globe. The Company lanched the Temporary Pacemaker (Indus-I) and has received number of orders from around the Country which will enhance profitability.

The Company is to launch some time in October 1999 another Cardiology Product called "CORONARY STENT" as its diversification efforts. We are confident that the Company will further enhance profitability through this product.

Semi Conductor Complex Ltd., Chandigrah and Department of Scientific and Industrial Research, New Delhi alongwith our Company have agreed to commence indiginisation effort for the development of ASIC, which is one of the major item imported by the Company and for which your Company has dependency on Imports.

The Company has also Launched Steroid Elluding Lead to have competitive edge as well as to increase the life time of the Pulse Generator significantly after implant.

To further reduce dependency on Import so as to provide our Distributors the Testing Machineries (such as PSA) the Company will Launch in September 99, the products ACELOG-I manufactured and developed by our own Company so that valuable Foreign Exchange is saved and Testing Machineries purchased is significantly reduced. To conclude, the Company expects to show better results in the year 1999-2000 with increase in Exports and internal demand as well as with above mentioned developments and indiginisation efforts.

5. CONSERVATION OF ENERGY, FOREIGN EXCHANGE EARNINGS AND OUT GO R & D AND TECHNOLOGY ABSORPTION:

6. PARTICULARS OF EMPLOYEES:

There are no employees falling under the purview of Section 217-(2A) of the Companies Act, 1956, read with the companies (Particulars of Employees) rules, 1975.

7. DEPOSITS :

The Company has not accepted any deposits from public during the year, hence the Provisions of Section 58-A of the Companies Act, 1956 do not apply.

8. Y2K COMPLIANCE:

The Company has taken necessary steps to make the Computer System Y2K compliant.

During the year under review Dr. S. K. Sethi and Dr. S. K. Sekaran retire by rotation and being eligible offers themselves for reappointment.
