


In the year ended 31 March 2006, we announced our decision to focus exclusively on Sical's core business of bulk and containerized logistics, and to hive off our non-core businesses.

In line with our focus, we changed our name from South India Corporation (Agencies) Ltd to Sical Logistics Ltd, and unveiled our new identity.

Towards funding our rapidly increasing business requirements, we decided to raise USD 75 million in foreign currency convertible bonds (FCCB), completing the issue in April 2006.

We won new contracts for increased coal handling at Tuticorin and Chennai ports, and for steel coils and slabs at Chennai. We added new clients to all our businesses, especially in port handling, trucking, and container logistics.



#### Sical Distriparks Ltd

Formerly a JV with a Port of Singapore Authority subsidiary. Sical and associates now own 90% of the company's equity—55 acre container freight station near Chennai, India.

#### **PSA-Sical Terminals Ltd**

Joint venture with PSA Corporation, Singapore, for container terminal at Tuticorin, India.

### Major contracts

#### Coal handling | Tamil Nadu Electricity Board

Scope: To handle 8 million MT of coal annually. The work: unloading of ship cargo using 2 shore-based cranes and providing mobile hopper for receiving cargo from a self-discharging ship. Build-operate-transfer (BOT) model with Rs 900 million investment from Sical.

#### Container stations | Central Warehousing Corporation

Scope: Operations and management of CWC's container freight stations at the ports of Nhava Sheva, Visakhapatnam and Tuticorin, and CWC's inland container depot at Noida. The infrastructure is owned by CWC; Sical is responsible for operations and marketing to end-customers such as shipping lines and large manufacturers.

#### Offshore vessels logistics | Oil and Natural Gas Corporation

Scope: Sical manages 15 of ONGC's OSVs. An OSV carries the supplies that an offshore rig or platform requires for day-to-day operations, such as drilling equipment, mud, tubulars, oil and lubricants, food and water. Sical's responsibility includes manning, victualing, operation, technical management, maintenance and repair.

#### Road transport | Caltex, TN Petro, Pepsi, Shell

Scope: For Caltex, Sical moves LPG, in bulk and in cylinders, across the Indian states of Tamil Nadu, Karnataka, and Kerala. For TN Petro, Sical moves linear alkyl benzene (LAB), benzene and heavy normal paraffin across the states of Tamil Nadu, Karnataka, Pondicherry, Madhya Pradesh, Uttar Pradesh, Himachal Pradesh, and West Bengal. For Pepsi India, Sical moves beverages and mineral water across the states of Tamil Nadu, Kerala, Karnataka, Goa, and Maharashtra. For Shell India, Sical transports Shell petroleum products across India's southern states.

#### Container terminals | Tuticorin Port Trust

Under a 30 year contract by the Tuticorin Port Trust, India, the Sical-Port of Singapore Authority (PSA) alliance operates and manages the container terminal at Tuticorin port. Facilities include 250,000 square feet of open bonded area, and a container stacking capacity of 3,000 TEUs.


