EXPLANATORY STATEMENT PURSUANT TO SEC 173 (2) OF THE COMPANIES ACT, 1956

<u>Items Nos. 4 & 5</u>

Shri Abhishek Poddar and Shri Kanhaiya Khaitan were appointed Additional Directors during the year and in terms of the provision u/s 258 of the Companies Act, 1956. Shri Poddar and Shri Khaitan are due to retire at the conclusion of the ensuing Annual General Meeting. Whereas the Company has since received 2 Nos. Notice u/s 257 of the Act from 2 members of the Company indicating their desire to move the resolutions as set out under item nos. 4&5 for appointing Shri Poddar and Shri Khaitan as Directors of the Company.

Your Directors consider that appointment of Shri Poddar and Shri Khaitan as Directors will be beneficial for smooth conduct of Company's business and accordingly they recommend the resolutions for adoption.

None of the Directors other than Shri Poddar and Shri Khaitan are interested or conserved in these resolutions.

Item No. 6

Consequent to the passing of the Depositories Act, 1996 and introduction of the Depository System, some of the provisions of the Companies Act, 1956 pertaining to issue, transfer and dealings in shares and securities and holdings thereof have been amended to facilitate the Depository System. The proposed alteration of the Articles as set out in the resolution under Item No. 6 of the notice is intended to bring the Articles of Association in line with the provisions of the Depositories Act, 1996.

The Directors recommend the resolution for adoption. None of the Directors are personally interested or concerned in this resolution.
