



The Company, on a consolidated basis, had accumulated reserves and surplus to the tune of Rs. 579.30 million.



#### Source of inspiration and constant guidance - Shri H. L. Somany

Shri Hira Lal Somany was born in 1920. He jumped into the family business at Kolkata Stock Exchange in 1936 when he was just 16 and set about gradually converting the business into an industry.

Shri HL Somany is the founder of Somany Ceramics Limited (formerly known as SPL LIMITED), and established this organization in 1970 in collaboration with Pilkington's Tiles Ltd of UK.

In 1944, he established Somany Glass Works Ltd. And in 1951, he started an automatic Glass Plant and also took over the management of Simplex Mills in Mumbai. 1960 was another 342 watershed year. That year, he established Sanitaryware manufacturing plant at Bahadurgarh in Haryana, now known as Hindustan Sanitaryware and Industries Ltd. He also established Hindustan National Glass & Industries Ltd, and stated a textile unit by the name of Soma

Textiles & Industries Ltd in the same year.

Shri HL Somany has had the distinction of leading many high level business delegations to Singapore, Thailand, Hong Kong, Manila, Australia, Indonesia, East Africa, Middle East, Iraq, Iran etc.

He has served as President of Assocham in 1996-1997, besides holding the position of President of Merchant Chambers of Commerce in 1980-1981.

That's not all. Shri Somany also served as the Chairman of Capexil, an export promotion organization. He has also been very closely associated with various other forums including Sangeet Kala Mandir (a musical hub of Kolkata) and SAMAGAM (a musical hub of Delhi).

He is the founder of Schablona India Limited, and keeps himself abreast with its day-to-day operations.


