**NOTICE TO MEMBERS**

Dear Shareholder,

### THE DEPOSITORY SYSTEM FOR SHARES

We are pleased to inform you that your Company has enlisted its Equity Shares with National Securities Depository Ltd. which would facilitate investors to hold and trade in the Equity Shares of the Company in electronic form. Through this letter, we are informing you about the salient features of the Depository System which would assist you in deciding to opt for holding your securities in electronic form.

The need for a Depository in India was felt for quite some time, especially due to the problems associated with handling large volumes of paper and other difficulties such as bad deliveries, fake certificates, loss of certificates in transit, mutilation of certificates, delays in transfer, long settlement cycles, etc. To provide a reliable and efficient solution to the above mentioned problems, National Securities Depository Limited (NSDL) has been set up as the first depository in India. NSDL has a capital base of Rs. 100 crore and has been promoted by IDBI, UTI, NSE and others.

#### 1. What is a Depository ?

A Depository is an organisation which holds your securities in the form of electronic book entries in the same way a bank holds your money. Further, a depository transfers securities without physically handling securities, the way a bank transfers funds without actually handling money.

#### 2. Benefits to an investor

- No stamp duty for transfer of Securities in the depository. In case of physical transfer of shares, stamp duty of 0.5% is payable.
- Elimination of bad deliveries and all risks associated with physical certificates such as loss in transit, theft, mutilation, etc.
- After the settlement, pay in and out are on the same day for scripless trading, which means you get your securities as well as cash quickly.
- Securities stand transferred in the name of the buyer on the next day of pay out. In case of physical transfer of shares, the processing of transfer takes at least 30 days.
- No courier/postal charges.
- Facility for freezing/locking of investor accounts, enabling you to make your account non-operational, for instance, if you are abroad.
- Facility to pledge and hypothecate your securities.

#### 3. Services offered by NSDL

NSDL offers the following services to the investors through its agents, viz. Depository Participants :

- Maintenance of investors' beneficial holding in electronic form.
- Dematerialisation and rematerialisation of securities.
- Facilitation of settlement of trades in electronic shares.
- Electronic credit in case of public offerings and non-cash corporate actions such as rights, bonus, etc.
- Statement of holding and Statement of transaction.

#### 4. How to convert your physical shares to Electronic Holdings (Dematerialisation)

For the purpose of joining the depository system and to convert your physical shares into electronic holdings, you are required to do the following :-

- (a) Open an account with one of the participants of NSDL. A participant is a market intermediary through whom NSDL interacts with the investors. Annexure A gives a list of participants who are presently offering depository services. Choose a participant and :
  - (i) fill up an Account opening form available with the Participant (you can open multiple accounts with same participant as also with different participants).
  - (ii) sign "Participant—Client Agreement" and obtain a copy thereof.
  - (iii) Receive your account number which should be noted in all your correspondence with your participant.
  - (iv) Fill a Dematerialisation Request form available with your Depository Participant.
  - (v) Submit your Share Certificates along with the above form to your Depository Participant and get an acknowledgement from the Depository Participant. In the normal course, these share certificates will be cancelled by the Depository Participant in your presence to prevent any misuse thereof. Please ensure that the Certificates surrendered for dematerialisation are defaced "Surrendered for Demat".
  - (vi) The Dematerialisation Request Form along with the share certificates will be sent by the Depository

Participant to the Registrars. At the same time, an electronic request will be sent to the Registrars through NSDL Network.

- (vii) Our Registrars will verify the certificates and the request and if found in order, will cancel the physical certificates and confirm the dematerialisation to NSDL. NSDL will in turn confirm the dematerialisation to the Depository Participant.
- (viii) On receiving the confirmation, your Depository participant will credit your account with the number of shares so dematerialised and thereafter you will be holding the shares in electronic form. Normally, your account will be credited within 15 days.
- (ix) Your Depository Participant will give you a statement of holding and will update your account after each transaction like your bank account.
- (x) In case the request for demat is rejected on any technical ground, you may consider making an application to the Company for issue of duplicate certificates.

#### 5. Corporate Benefits

Once you convert your shares into electronic form, we will be substituting NSDL as the registered owner for these shares in our books. However, all corporate benefits like Dividend, Rights, Bonus will be issued to the beneficial owners i.e., the shareholders holding shares in electronic form. For the purpose of Dividend payment, NSDL will provide us with the details of the shareholders and accordingly the dividend when paid will be sent by us directly to you. Similarly for Bonus / Rights Issues, the distribution of the Bonus / Rights entitlement will be done electronically to your account and the bonus share certificates will not be sent to you.

#### 6. Rematerialisation of Shares

If at any time you wish to convert your holding of shares in electronic form back to physical scrips, you may do so by applying for rematerialisation through your Depository participant.

#### 7. Pledge / Hypothecation etc.

You can take loans from banks by pledging your shares held in the electronic form. The details can be obtained from your Depository Participant.

#### 8. How do you trade in electronic shares ?

The Equity Shares of the Company are available for trading on the Stock Exchange, Mumbai, Calcutta Stock Exchange and National Stock Exchange in the Electronic segment. Buying and selling shares in the electronic form is just like buying and selling physical shares, the only difference is in delivery of securities in the electronic form which is simpler and safer.

If you wish to sell your shares, you place an order with your broker and instruct your participant by way of Delivery Instruction (which is a cheque-like instrument) to debit your account with the number of shares sold by you.

When you buy shares, you must inform your broker about your depository account number so that the shares bought by you are credited into your account and instruct your participant by way of Receipt Instruction to receive credit in your account.

Payment for the electronic shares either bought or sold is made in the same way as in case of physical securities.

The shares you have bought are transferred in your name the very next day of pay out. No formalities of executing transfer deeds, affixing share transfer stamps and applying to the Company for registering the shares in your name are required to be observed.

#### 9. Cost of Trading in Electronic Mode

Each Depository Participant charges its clients a certain amount of fees in addition to the fees charged to them by NSDL. These charges are by way of account opening fees, transaction fees, custody fees, etc. and the rate of fee is not uniform with all Depository Participants. You should, therefore, check the fee structure of the Depository Participant.
