

#### MANAGEMENT DISCUSSION & ANALYSIS REPORT, REVIEW OF OPERATIONS DURING THE YEAR & FUTURE PLANS:

Although Company could procure and execute the job work assignment for the product frozen peas but not for the entire peas capacity resulting in reduction in the operating margins. As regards frozen sweet corn, the company targeted institutional sales in the year under review and was able to satisfactorily increase sales in that segment. The management is trying to raise alternate debts to repay the existing lenders offering them negotiated settlement in order to reduce debt burden of the company.

The Company was in receipt of Notice under Rule 4(1) of SEBI (Procedure for Holding Enquiry and Imposing Penalties by Adjudicating Officer) Rules, 1995 from Securities and Exchange Board of India pertaining to period 2005-06.

Due to the losses incurred by your company, no dividend is recommended on the equity shares of the company.
