Yours directors have pleasure in presenting the Nineteenth Annual Report together with the Audited Statement of Accounts for the year ended 31st March, 1999.

FINANCIAL RESULTS :

During the year under review, the Company has earned profit of Rs.1,32,374/- as against Rs.23,74,275/-. After making provision for taxation for Rs.45,000/-, the net profit was Rs.85,375/- as against previous year Rs.23,29,275/-,
