During the year under review, the Company has incurred loss of Rs.65,706/- as against Previous year loss of Rs.59,825/-. In view of loss, the directors do not recommend any dividend for the period ended March 31, 2009.

The company has not accepted Fixed Deposits from the Public during the year and no deposits remain outstanding for repayment.

The Annual General Meeting for the financial year ended on 31st March, 2008 was held on 29th September 2008 and as per information and explanation given by the management, the Company has given adequate notice to all its members and the resolutions passed thereat were duly recorded in the Minutes Book maintained for the purpose.
- 7. No extra-ordinary general meeting was held during the financial year.

- 8. The Company has not advanced any loans to its directors or persons or firms or companies referred to under Section 295 of the Act.
- The Company has not entered into any contracts falling within the purview of Section 297 of the Act.
- 10. The Company has made necessary entries in the register maintained under Section 301 of the Act.
- As there were no instances falling within the purview of Section 314 of the Act, the Company has not obtained any approvals from the Board of Directors, members or Central Government.
