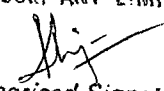

1. As required by the Manufacturing and Other Companies ( Auditors' Report) Order, 1988, issued by the Company Law Board in terms of Section 227(4A) of the Companies Act, 1956, We enclose in the Annexure a statement on the matters specified in paragraphs 4 and 5 of the said order.
2. Further to our comments in the Annexure referred to in paragraph 1 above we report that :
  - (a) We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of our audit.
  - (b) In our opinion, proper books of account as required by law have been kept by the company so far as appears from our examination of such books.
  - (c) The Balance Sheet and Profit and Loss Account referred to in this report are in agreement with the books of account.
  - (d) In our opinion and to the best of our information and according to the explanations given to us, the said Balance Sheet and Profit and Loss Account read together with the notes thereon, give the information required under the Companies Act, 1956 in the manner so required and subject to (1) The company is not registered with RBI as per provisions of sec.45 IA OF Reserve Bank of India Act '34 : (2) Advances of substantial amounts given to parties for procurement of shares are received back after considerable time without procuring shares. At the year end Rs.2.25 crores is outstanding from parties on this account. We are unable to comment since neither shares nor the advance has been received back till date; give a true and fair view:
