Mr. Jaikumar Kumar Sarawgi and Smt. Roharan Sarawgi retires by rotation and being eligible offer themselves for re-appointment.



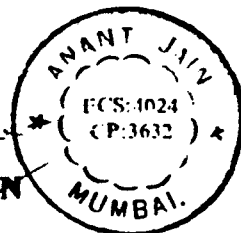
